#### Points to note on release of the contingency bid

Release of the bid is a condition of The Treasury's Regulation Impact Assessment process, as outlined in the Cabinet paper. There are some points to note about the release of this document:

- The table of overall estimates for the implementation of Emergency Housing Special Needs Grants (EH SNG) (page 4) is out of date. The estimates were revised and replaced by in the Cabinet paper Aotearoa/New Zealand Homelessness Action Plan (para 66)
- The final system changes for implementation of the policy are noted as being implemented by June/July 2020 (page 2). They are being rolled out from this date.

#### **Background**

On 11 December 2019, the Cabinet Social Wellbeing Committee approved the Aotearoa/New Zealand Homelessness Action Plan Phase I (2020-2023) and to changes to the policy settings for EH SNGs.

The EH SNG policy changes introduce an emergency housing contribution made by clients granted an EH SNG and provide MSD the discretion to extend the duration of some EH SNGs in specified circumstances.

To enable the policy changes, amendments were required to the Social Security Regulations 2018. The Amendment Regulations can be found at:

Cabinet subsequently agreed to a number of temporary changes to MSD's operating model to facilitate responses to COVID-19. At this time, the commencement of the emergency housing contribution, was deferred to help free-up MSD's frontline resources to deliver responses to the pandemic. The contribution was originally intended to be effective from 30 March 2020. There will be further communication to clients and relevant stakeholders when the new date for the contribution to come into effect is confirmed.

Some parts of this information release would not be appropriate to release and, if requested, would be withheld under the Official Information Act 1982 (the Act). Where this is the case, the relevant sections of the Act that would apply have been identified.
