When can we expect to see comparisons and useable results from this piece of work? Yes, there is a timing issue though we will get some useful insights from the first data collection on who is actually using our services and are they the people we thought would. The result data will become richer over time as you observe as customers work with providers, and then as we build up more data on what sort of results different customers get from different services from different providers
- 4. What progress has been made with providers who may have exemptions due to the sensitivity of the clients they work with? If the decisions been made to not have any exemptions how are we managing that? We've not had to deal with any exemptions to date in the first tranche, given who's involved in that. We'll work through possible exemptions in the next phase though I expect they'll be fairly self-evident
