• The number of parents on each main benefit for the most recent full year broken down by the ages of children eg 0-4 years, 5-9 years, 10-13 years, 14-17 years, 18-19 years and the number of dependent children ie 1, 2, 3, 4, 5+.

Please find enclosed two tables. Table one shows the number of parents in receipt of a main benefit, broken down by main benefit type and the age of the clients' children. Table two shows the number of parents in receipt of a main benefit, broken down by the number of dependent children per client.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter available to the wider public after ten working days. The Ministry will do this by publishing this letter on the Ministry of Social Development's website. Your personal details will be deleted and the Ministry will not publish any information that would identify you as the person who requested the information.
