On 3 April 2017 you emailed the Ministry requesting, under the Official Information  $Act\ 1982$ , the following information:

 A copy of the current Housing Supplier List available to Work and Income case managers in Auckland for emergency accommodation, including provider name, address, accommodation type, and contact phone number.

Please find enclosed a copy of the list from the 'Auckland Emergency Housing Centralised Register' as at 7 April 2017. The Auckland emergency housing centralised register (the centralised register) is a tool that allows staff to search for vacant placements in Auckland with contracted emergency housing providers (denoted EHP in the document), that clients can be referred to. It also lists vacancies with alternative commercial accommodation (denoted paid opportunity in the document) that clients can be advised about, available to address a client's emergency housing need if they so choose.

The centralised register database is updated when the emergency housing providers advise of a vacancy and/or when a new provider is contracted and confirmed. Updates are completed manually by a Housing Liaison Officer. On a daily basis the Housing Liaison Officer is in regular contact with the contracted emergency housing providers to identify available vacancies and services for vulnerable clients. This information is then used to update the Emergency Housing centralised register.

All staff in Auckland service centres can identify available accommodation using the centralised register when assisting a client. This streamlines the process for referring a client to appropriate contracted emergency housing providers, or to advise clients of available alternative paid accommodation, as Ministry staff do not have to spend time ringing around multiple providers to identify if any appropriate vacancies are available. This helps vulnerable clients and their families access emergency housing promptly.

There are a range of emergency vacancies and services available that cater to the needs of different types of households. For example, there are providers who are more suited to families with young children whilst other providers are suitable for women and children. The Ministry's Case Managers are able to search for vacancies and can narrow their searches according to client requirements, for instance:

- Who the vacancy or accommodation is most suitable for
- What wrap around support/service is provided
- Vacancy type
- Area of Auckland
- Nearest Work and Income service centre.

Boarding houses are not contracted emergency housing providers and the Ministry does not have a preference for them over any other accommodation provider. The policy in Auckland is that no direct referrals to boarding houses are made. Decisions about where a client will stay are generally driven by availability and ultimately it is the client's decision. The Ministry is not responsible for vetting the commercial accommodation.

Staff can also use the information in the register to confirm a property's details if clients have self-referred and later approached the Ministry for rental assistance.

Please note that where there is a P.O Box number only, this is at the request of Refuges for safety and privacy purposes. Some of the accommodation providers' staff names and mobile numbers are withheld under section 9(2)(a) of the Act to protect the privacy of natural persons. The need to protect the privacy of these individuals outweighs any public interest in this information.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any attached documents available to the wider public shortly. The Ministry will do this by publishing this letter and attachments on the Ministry of Social Development's website. Your personal details will be deleted and the Ministry will not publish any information that would identify you as the person who requested the information.
