On 1 December 2016 you emailed the Ministry requesting, under the Official Information Act 1982, information regarding the number of children who were abused in care where facilities were run in collaboration with the Catholic Church or other religious institutions from 1940 to 1990.

Historically, where it was necessary for children and young people to be taken into state care, the significant majority were placed either in foster homes, family homes, residential care or the care of family or Whānau members. A small number of children may have been placed into homes run by churches or philanthropic organisations.

Various boys' and girls' homes were established and administered by the predecessor organisations of the Ministry, including the Child Welfare Division of the Department of Education, the Department of Social Welfare and the New Zealand Children and Young Persons Service. These institutions were administered exclusively by the state and with no assistance, management or in collaboration with any church or philanthropic organisation.

As noted above, various churches and philanthropic organisations also established and administered a variety of different homes. They were administered exclusively by the owning organisation. The sole involvement that the state had with such homes was the inspection and approval of them by the then equivalent of the Ministry under the relevant provisions of the legislation applicable at the time. As such, I am refusing your request under section 18(g) of the Official Information Act as the information you have requested is not held by the Ministry and I have no grounds to believe that the information is held by another department or Minister of the Crown or organisation.

Psychiatric hospitals and health camps on the other hand were administered by the Ministry of Health, while residential education institutions were administered by the Ministry of Education.

The enclosed table is a list of the residential institutions run by the Ministry's predecessors until circa 1990.

Where a person makes a claim that they were abused or otherwise harmed while in the care of the Ministry, then we are committed to resolve that claim wherever possible. Claims received to date cover many decades, all types or care arrangements and they allege abuse and neglect across the spectrum of severity.

Where there is the basis to do so, the claimant will receive a formal written apology from the Ministry's Chief Executive and a financial payment as acknowledgement of the harm they came to.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any attached documents available to the wider public after ten working days. The Ministry will do this by publishing this letter on the Ministry of Social Development's website. Your personal details will be deleted and the Ministry will not publish any information that would identify you as the person who requested the information.
