On 30 May 2018, you emailed the Ministry requesting, under the Official Information Act 1982, the following information:

- How many people apply for the Residential Care Subsidy for the first time each year?
- Of those who apply for the first time, how many people are granted the subsidy?
- How many people, who are first time applicants, are declined?
- How many people, who are first time applicants, are declined based on the asset test?
- How many people re-apply for the Residential Care Subsidy each year after being previously declined?
- Of those who re-apply, how many are granted the subsidy?
- How many people are declined when re-applying?
- How many people are declined when re-applying based on the asset test?

People who need long-term residential care in a hospital or rest home, may be able to get a Residential Care Subsidy from the Ministry of Health. The Ministry of Social Development (the Ministry) administers Residential Care Subsidy including income and asset testing people who apply, but Residential Care Subsidy is funded by the Ministry of Health. Please find below two tables that address your questions. As you were advised by a Ministry official, due to limitations in reporting, the Ministry has determined 'first time application' and 're-application after previously being declined' based on events that occurred in the five years prior to the period being reported.

Number of Residential Care Subsidy applications from people who had not made an application in five years preceding the reported financial years, broken down by outcome of the application, for the 2014/15, 2015/16, and 2016/17 financial years.

Notes:

- Applications counted are the first application in the fiscal year where there has been no application in the five fiscal years prior.
- If an application is declined and then granted on the same day, then only the 'grant' action is counted.

Number of reapplications for Residential Care Subsidy following a 'decline' in the five years prior to the reported financial years, broken down by outcome of the application, for the 2014/15, 2015/16, and 2016/17 financial years.

Notes:

- Reapplications counted are clients whose most recent prior application was a 'declined' application, and was in the five years prior to the reapplication.
- If a client had a grant after a decline in the five years prior to the reported year, then a reapplication, it is not considered as a reapplication following a decline.
- The 'decline' is the last decline prior to the reapplication. Only the reapplication following the last 'decline' is counted.
- If there is a 'decline' and a 'grant' on the same day, then the 'grant' action is counted.

The reason of 'Other' for decline of an application may include:

- Client has died
- application has been withdrawn by applicant
- insufficient information provided in application prior to manual lapse date

There are a variety of reasons why a person who has previously had an application for Residential Care Subsidy declined would then have a subsequent application granted. For instance, if the applicant's funds drop below the asset threshold an application that was previously declined would then be granted.
