On 5 June 2019 you emailed the Ministry requesting, under the Official Information Act 1982, the following information regarding Emergency Housing Special Needs Grant (EH SNG) payments over the last two years:

- The number of accommodation providers who have received funds through the emergency grants.
- A list of names and locations of those accommodation providers.
- The amount of money each of those accommodation providers has received.
- The maximum amount of money given to an accommodation provider.
- The maximum that has been spent on any one client.
- The total sum given to accommodation provider in the last two years.

On 14 June 2019, the request was clarified for the following information regarding EH SNGs granted over the last two years:

- The number of accommodation providers who have received funds through the emergency grants broken down by region.
- The total sum given to accommodation provider in the last two years nationally.
- The maximum amount of money given to an accommodation provider.
- The maximum that has been spent on any one client.
- The 20 accommodation providers that have received the greatest amount of EHSNG grant funding for each region, including names of each provider, total amount paid and average amount granted.

The Ministry assists those in urgent need of housing. Anyone who requires urgent accommodation can call 0800 559 009.

The Emergency Housing Special Needs Grant was introduced on 1 July 2016 in order to fund temporary accommodation at places such as hostels and motels to meet people's immediate housing needs. This grant is paid to help meet the cost of short-term accommodation where no transitional housing is available. The Ministry acknowledges that motels are not a long-term solution, particularly for vulnerable people with complex needs, but they provide a short-term solution while more sustainable options are progressed. It is important that those who would otherwise be homeless have somewhere warm and dry to stay.

The Ministry pays EH SNGs directly to the accommodation suppliers. This grant is available to people who cannot remain in their usual place of residence, if any, and do not have access to other accommodation which is adequate for them or their family's needs. Assistance is generally granted for up to seven nights but can be extended dependent on an individual's circumstances. In most cases, this does not need to be paid back, though this will depend on a household's situation.

A small number of people have exceptional circumstances that result in them receiving EH SNG support for an extended period of time. I can advise that the maximum amount granted to a single client within the period 1 July 2017 to 30 June 2019 is \$140,220. In this instance, the individual required a modified house due to a disability over an extended period of time. This client is now living in a private rental property that has been modified to support their needs.

The maximum amount of money granted to an accommodation supplier is \$5,269,936. Please note that the amount granted may not be the same as the amount spent. This was granted to Auckland Astro Residences Limited during the period between 1 July 2017 to 30 June 2019. Auckland Astro Residences Limited is no longer being used for emergency housing under the SNG as at the date of this response.

Emergency accommodation suppliers contribute a vital service. The Ministry maintains an ongoing relationship with them to ensure clients receive an appropriate quality of service and standard of accommodation other paying guests would expect. The Ministry continues to monitor clients' experience in the motels and resolve issues as they arise. On occassion, the Ministry may cease to pay grants to particular suppliers for various reasons. Please note that some of the listed suppliers may no longer be current suppliers.

Notes:

- The region of the Emergency Housing supplier is not stored in MSD systems. This data is the number
 of suppliers where a grant was granted in each region based on the Work and Income region where
 the recommending case manager for the application was based at the time of the grant. Clients
 can have grants for the same supplier from different regions, and as such some suppliers are
 counted more than once in the data. This is why the sum of the individual regions is not the same
 as the national total.
- A client may not necessarily reside in the same area as their Service Centre, as such their EH SNGs
 could be recorded in another region.
- The "Other" region includes suppliers who have been paid EH SNGs that have been approved by a
 Case Manager or Ministry staff member from non-regional service centres such as the Centralised
 Unit Housing Service Centre, Studylink Processing Centre, National Office and NZ Super Service
 Centres.

- The region of the Emergency Housing supplier is not stored in MSD systems. Region is based on the Work and Income region where the recommending case manager for the application was based at the time of the grant.
- A provider may be included in more than one Region in the above table if they had grants granted
 in more than one region. As such, the total amounts granted are only for grants made in the
 corresponding region.
- The "Other" region includes suppliers who have been paid EH SNGs that have been approved by a
 Case Manager or Ministry staff member from non-regional service centres such as the Centralised
 Unit Housing Service Centre, Studylink Processing Centre, National Office and NZ Super Service
 Centres.
- Names of accommodation suppliers are manually entered, and there may be different names for a single supplier, and or multiple supplier identifiers.
- The supplier name is the name of the company or individuals that own or provide the accommodation, and not necessarily the name of the accommodation.
- Some suppliers may have more than one identifier (supplier ID) and this may result in their amount being recorded in parts. It is possible (but unlikely) that this process has correctly identified the suppliers who are in the top 20 suppliers for a region.
- Grants paid directly to clients have not been included.
- (*) refers to accommodation suppliers that are no longer providing emergency housing under the SNG, as at the date of this response. This information has not been noted for Canterbury and "Other" regions.
