

Dear

On 23 January 2019, you emailed the Ministry requesting, under the Official Information Act 1982, a range of information relating to emergency hardship assistance in the South Waikato area. This was later refined by you to mean the Tokoroa Service Centre.

Special Needs Grants provide financial assistance to meet immediate, essential needs. The grant is non-taxable and a person does not need to be receiving a benefit to qualify for a Special Needs Grant. Sometimes the grant needs to be repaid and sometimes it does not. Special Needs Grants can be used to meet a range of needs, Emergency Housing and food are two of these.

Your questions are addressed in turn below:

• Number of applications and applicants for food grants in South Waikato and number declined for the years 2009-2018 inclusive and the same data for the whole of NZ.

Please find enclosed table one which shows the number of Special Needs Grant applications for food granted and declined for the years 2013 to 2018 in Tokoroa and nationally.

The Ministry's reporting capabilities were improved from the 2013 calendar year. The Ministry is unable to provide data about applications for Special Needs Grants for food broken down by whether they were granted or declined for the 2009 to 2012 calendar years without the creation of new reporting or manually reviewing client files. As such, your request is partially refused under section 18(f) of the Act. The greater public interest is in the effective and efficient administration of the public service.

Throughout the response where parts of your request have been refused under section 18(f) of the Act, it has been considered whether the Ministry would be able to respond to your request given extra time, or the ability to charge for the information requested. It is concluded that, in either case, the Ministry's ability to undertake its work would still be prejudiced.

• Reasons provided for declining food grants in South Waikato for the calendar year 2018 and the same data for all of NZ.

Please find enclosed table two which shows the reasons for declining food grants in all of New Zealand and at the Tokoroa Service Centre in the 2018 calendar year

• Numbers of clients referred to charitable organisations when food grants are declined for South Waikato and the same data for all of NZ.

When someone asks Work and Income for emergency assistance to buy food, Work and Income will make sure that they are receiving their full and correct entitlement. This includes reviewing their benefit rate and debt recovery offsets and considering their eligibility to other supplementary assistance. If the person has no further entitlement to assistance and does not qualify for a Special Needs Grant for food, Work and Income will decline the application and provide a list of community agencies that may be able to assist.

The Ministry is unable to answer your question regarding the number of clients referred to charitable organisations following being declined for a food grant as it is held in notes on individual case files. In order to provide you with this information Ministry staff would have to manually review the files of all clients who were declined a food grant. As such this request is refused request under section 18(f) of the Official Information Act. The greater public interest is in the effective and efficient administration of the public service.

• Numbers of requests for emergency housing in South Waikato for the years 2009 to 2018 inclusive and the same data for all of NZ.

The Emergency Housing Special Needs Grant was introduced on 1 July 2016. Data for the first quarter that this grant was available is not in a format that allows ad-hoc reporting. As such, data is only available from October 2016. Providing the number of requests for emergency housing prior to this time would require substantial manual collation as individual files would need to be reviewed. As such, your request for this information is refused under section 18(f) of the Act.

Please find enclosed table three which shows the number of Special Needs Grant applications for Emergency Housing from October 2016 to the end of the 2018 calendar year for the Tokoroa Service Centre and nationally, broken down by whether the application was approved or declined.

Please also find enclosed table four which shows the number of clients who received a Special Needs Grant for Emergency Housing over the same time period for the Tokoroa Service Centre and nationally.

• Ethnicity of those declined for food grants and emergency accommodation in South Waikato in the calendar year 2018 and the same data for all of NZ.

Please find enclosed table five which shows the Ethnicity of those declined for Food and Emergency Housing Special Needs Grants, nationally and in Tokoroa in the 2018 calendar year.

• Numbers of beneficiaries with dependent children and without dependent children declined food grants and requests for emergency accommodation in South Waikato for the years 2009 to 2018 inclusive and the same data for all of NZ.

The number of children included in an application for a Special Needs Grant for food or Emergency Housing is held on the individual client record, and cannot be reported on electronically without the creation of new reporting, which would require a significant amount of resource. As such, your request is refused under section 18(f) of the Act. In order to provide you with this information Ministry staff would have to manually review the files of all clients who were declined a food grant and who applied for an Emergency Housing Special Needs Grant. The greater public interest is in the effective and efficient administration of the public service.

• Type of emergency accommodation provided to beneficiaries in South Waikato in the calendar year 2018 and the same data for all of NZ.

Please find enclosed table six which shows Emergency Housing Special Needs Grants for Tokoroa and nationally for the 2018 calendar year, broken down by the type of accommodation.
