Enclosed are copies of all correspondence relating to the recruitment of bus drivers by New Zealand Bus Ltd (NZ Bus), between 1 January 2018 and 15 February 2019.

Please note, the contact details of some individuals have been withheld under section 9(2)(k) of the Official Information Act in order to reduce the possibility of staff being exposed to phishing and other scams. This is because information released under the Official Information Act may end up in the public domain, for example, on websites including the Ministry's own website.

The names of some individuals are also withheld under section 9(2)(a) of the Official Information Act in order to protect the privacy of natural persons. The need to protect the privacy of these individuals outweighs any public interest in this information.

Information that is not directly related to NZ Bus Ltd is excluded from this response and is noted as 'Outside of Scope.'

Please note, a significant amount of information is also excluded from this response as it is repetitive in nature of the other documents in scope. For example where email trails are repeated in reply emails, they have only been included once.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any attached documents available to the wider public shortly. The Ministry will do this by publishing this letter and attachments on the Ministry of Social Development's website. Your personal details will be deleted and the Ministry will not publish any information that would identify you as the person who requested the information.

thanks for your patience. I would like to propose the following recruitment process in order to get the maximum candidate interaction and hopefully turn interactions into opportunities. We would like to run a recruitment seminar(s) in order to be more engaging:

- We hold the assessment centre @ Work and Income office/site this is an exclusive recruitment drive for NZ Bus only.
- Candidates for this seminar will be pre-screened by Job Connect based on the phone screening questions we
 provide them.
- Candidates present at this seminar will be shown our presentation and given the option to stay or leave for the next step.
- Next step is literacy, numeracy and road code test. This will take 45 minutes per applicant.

- We will check the answers and based on our benchmarks for candidates who passed will be paperwork to be completed – Info sheet, ref check, MOJ, PV etc.
- The passed candidates will be invited for the driving test + interview at NZ Bus City Depot. NZ Bus will work out the logistics of this and get arrange the interview for another day.
- Hopefully by then all the MOJs and DSH reports would have returned so we will be in the position to offer them the role pending driving test and interview.
- At all times, candidates are to be instructed that if they FAIL any pre-employment checks, the application wont be taken forward.

To get more out of this relationship, its viable for us to run a short assessment centre at your venue, get a buy in from the candidates that we are serious about hiring and then follow the proposal above.

Our minimum requirements are:

- Class 1 Full NZ Drivers licence held for minimum 2 years or more. If the licence is under 2 years, they need to provide an exemption given by NZTA.
- That passion of working and serving the community.
- Availability across all 7 days for rostered shifts. However they are only rostered for any 5 days out of those
 7. So if they have a Sunday religious service, they need to work around those hours for this role as buses are operational 24/7 365!
- Unlike many other jobs, Bus Driving is not really flexible the buses need to run, the routes need to be
 operational, customers need to travel, we have a role to play in making sure a smooth and efficient service
 is happening.
