On 13 January 2021, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982, the following information:

- 1. Average daily usage of the SuperGold website in the weeks between January 1st 2020 and 31st December 2020.
- 2. Average daily usage of the SuperGold mobile app in the weeks between January 1st 2020 and 31st December 2020.
- *3. Cumulative app download growth by month between January 2020 and December 2020.*
- 4. "SuperGold Digital Experience Updates" from Feb 2020 to December 2020.

The SuperGold Card is provided to seniors and veterans. The card provides access to discounts and offers from a wide range of businesses, government funded free off-peak public transport concessions, and services and discounts from local councils.

An increasing number of seniors own, and regularly use devices with internet access. As such, the Ministry is developing digital channels for SuperGold through a dedicated application (app) and website to allow seniors ease of access to information about their SuperGold card.

In response to questions one to four of your request, please find enclosed the following Appendix One. Question four has been interpreted as information on App update releases:

- **Table One** shows the average number of daily users for the SuperGold website, for each week between 1 January 2020 and 31 December 2020.
- **Table Two** shows the SuperGold Mobile App average number of daily users, for each week between 1 January 2020 and 31 December 2020.
- **Graph One** shows the SuperGold App downloads between 1 January 2020 and 31 December 2020.
- **Graph Two** shows the SuperGold App cumulative downloads between 1 January 2020 and 31 December 2020.
- **Table Three** shows the SuperGold App updates from February 2020 to December 2020.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any attached documents available to the wider public. The Ministry will do this by publishing this letter and attachments on the Ministry of Social Development's website. Your personal details will be deleted, and the Ministry will not publish any information that would identify you as the person who requested the information.


- Increased traffic from clients to the SuperGold website and app during certain weeks can be attributed to an eNewsletter campaign that contained SuperGold offers throughout the year.
