On 30 November 2020, you emailed Kāinga Ora, requesting under the Official Information Act 1982 (the Act) the following information:

- Is Kāinga Ora currently only housing those with a priority rating of A17 or higher?
- 2. Currently how many 3 Bedroom properties are available and ready to let in Christchurch city?

On 7 December 2020, question one of your request was transferred from Kāinga Ora to the Ministry of Social Development (the Ministry) for response because the information was more closely related to our functions and responsibilities. You can expect to receive a response from Kāinga Ora in response to question two of your request.

Background

Demand for housing across New Zealand is growing and more people are experiencing a severe and immediate need. This demand is generated by a shortage of affordable housing driving up house prices and rents. People on low incomes are most affected by rising housing costs and many seek financial help through the Ministry.

When New Zealanders are in need of public housing, their needs are recorded on either the Housing Register or the Transfer Register. While the Ministry completes the housing assessments which inform the Public Housing Register, responsibility for funding and the supply of houses sits with the Ministry of Housing and Urban Development and Kāinga Ora respectively. How people are housed

The Public Housing Register is dynamic rather than static, and it changes as people's circumstances and situations change. As such, the length of time spent on the Register awaiting housing can vary significantly. Placing people and families into houses is about matching them with the right house in the area they want to live. This includes ensuring the family has the right number of bedrooms and that the accommodation meets any disability needs if appropriate.

Therefore, in response to your question about whether Kāinga Ora are currently only housing those with a priority rating of A17 or higher, the Ministry can advise that whether someone is housed is not solely based on them having a certain priority rating (such as those with a rating of A17 or higher).

In addition to the priority rating, the type and location of the property has to match the preferred letting areas of an applicant and the required typology of the home (e.g. the number of bedrooms). When a house becomes available, MSD refer the highest prioritised applicants that would match the property to Kāinga Ora.

Other information

There is also a fast-track provision which recognises certain households applying for Public Housing are at risk of experiencing negative outcomes and that getting the household into Public Housing more quickly will help improve their long-term outcomes.

A household can be fast-tracked into the next available (suitable) public housing property even if there are other people with a higher priority rating in the following circumstances:

- the household has children at risk of rheumatic fever designated by North Island District Health Board areas only
- the household has a specified child or young person who is in custody under the Oranga Tamariki Act 1989 or is in an approved permanent care arrangement.
