On 16 June 2021, you emailed the Office of Hon David Parker requesting, under the Official Information Act 1982 (the Act), the following information:

- Please supply me with a list of industries which currently do not have the ability to deduct interest from loans for operational expenses.
- Please supply me with the waiting list number as at the date the Labour coalition came to office as well as the number on the waiting list as at 01/06/2021.

On 16 June 2021, the second question of your request was transferred in part to the Office of Hon Poto Williams, Associate Minister of Housing for response as it was believed to be more closely connected to the Minister's portfolio responsibilities.

On 17 June 2021, the second question of your request was transferred the Ministry of Social Development (the Ministry) for response.

The Ministry does not record Housing Register information for exact dates as Social Housing Register reporting for the Ministry is completed at the end of each quarter. As such, the Ministry is unable to supply information for 6 November 2020, and 1 June 2021, and you agreed to accept month-end data, that is Housing Register numbers as at 31 October 2020, and 31 May 2021.

The Ministry of Housing and Urban Development (HUD) publishes Public Housing quarterly reports and monthly updates which include Housing Register information as at the end of the quarter and month. Therefore, your request for this information is refused under section 18(d) of the Act on the basis that the information requested is now or will soon be publicly available.
