On 11 February 2021, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

• Any cost benefit analysis that the Ministry has made on Temporary Emergency Accommodation vs paying market rental for suitable property.

The Ministry has not completed any cost benefit analysis on Temporary Emergency Accommodation vs paying market rental for suitable property. Therefore, I am refusing your request under section 18(g) of the Act as the information you have requested is not held by the Ministry and I have no grounds to believe that the information is held by another department, or Minister of the Crown, or organisation.

However, the Ministry has investigated the average costs of our different housing supports such as Accommodation Supplement, Income-Related Rent Subsidy, and Emergency Accommodation.

In the spirit of being helpful, please find enclosed a document displaying the Ministry's assistance to support people across the housing market. A bullet point has been redacted on this document under section 9(2)(f)(iv), as it is under active consideration. The release of this information is likely to prejudice the ability of government to consider advice and the wider public interest of effective government would not be served.

Housing Assistance overview

Accommodation Supplement: A weekly payment to help people with their accommodation costs (rent, board, mortgage payments). Subsidy level tied to income, cash assets, household size & location.

Income Related Rent Subsidy: Payment for Public Housing Tenants. Beneficiaries pay 25% of their benefit; Non-beneficiaries pay 25% below income threshold and 50% for each \$ above income threshold. Above an amount market rent is paid.

EH SNGs: Payment to help individuals and families with cost of staying in short-term emergency housing.

Temporary Additional Support: Weekly payment to help people cover essential living costs

Housing Support Products: Various products available to help households access and retain alternative housing (to Public Housing). Are usually last resort payments for clients where they have exhausted all other options and includes:

- Recoverable Assistance Payments
- · Rent in advance
- Rent Arrears Assistance
- Moving Assistance
- Tenancy Costs Cover
- Statement of Satisfactory Tenancy

Analysis

Accommodation Supplement is a key support that can help people maintain sustainable housing. It
makes up MSD's largest housing assistance spend. Over the March 2020 Quarter, it cost \$426m
and supported 317,527 clients. Despite this, it offers one of the smallest spends per head.

 The spend on Emergency Housing does not represent value for money, as at the March quarter, 6,341 clients were supported with an EH SNG, costing the Government \$54.1 million. The average cost of an EH SNG is around \$1500 per week.
