On 10 March 2021, the Ministry of Social Development (the Ministry) was transferred your request dated 2 March 2021 from the Office of Hon Carmel Sepuloni, Minister for Social Development and Employment.

Under the Official Information Act 1982 (the Act) you requested the following information:

• The most recent figures available for the cost of National Superannuation during the last five years.

New Zealand Superannuation (NZS) provides a retirement income for New Zealanders who have reached 65 years of age.

On 9 November 2020, the NZS Scheme was updated after the Government agreed to change the following two aspects of the direct deduction policy:

- the amount of an overseas pension that is in excess of one partner's entitlement to NZS will no longer be deducted from their partner's NZS, and
- the amount of any overseas pension that comprises voluntary contributions made to an overseas pension scheme will also not be deducted.

The Ministry will do this by publishing this letter on the Ministry of Social Development's website. Your personal details will be deleted, and the Ministry will not publish any information that would identify you as the person who requested the information.
