On 13 September 2021, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982, the following information regarding recommendation four of the Office of the Auditor-General Management of the Wage Subsidy Scheme report:

• Provide copies of correspondence, how many recipients received this correspondence, and how those recipients were chosen (if a sub-group was identified). The timeframe of my request is April 1 to today's date.

- Email template Confirming Wage Subsidy 2020 eligibility and obligations

The following memo Wage Subsidy Scheme: Audit NZ and OAG Recommendations, has been identified as in scope of your request which has been attached to your other Wage Subsidy Scheme Official information request dated 13 September 2021. How samples were selected is detailed in the memo.

The following email template correspondence was sent to the email addresses of 1,000 applications for the Wage Subsidy Scheme has been determined to be in scope of your request.
