On 30 May 2022, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

- We would like to request, under the Official Information Act, details of all Official Information Act requests to the agency since November 2020 made by, or on behalf of the Taxpayers Union. This could include requests from Jordan Williams, Louis Houlbrooke, Casey Costello, Levi Gibbs or Connor Molloy.
- We are also interested in requests made under the name John Schmidt.
- It is not necessary to provide the responses, merely the information which was requested.

Please find attached **Appendix One** containing **Table One** with a list of Official Information Act requests made by, or on behalf of, the Taxpayers' Union between 1 November 2020 to 30 May 2022.

Additionally, the Ministry could not locate any Official Information Act requests made under the name John Schmidt for the same period. As such, this section of your request is refused under section 18(e) of the Act as the information requested does not exist.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

The Ministry will do this by publishing this letter and attachments on the Ministry's website.
