On 11 August 2022, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

- the latest figures for overseas govt pensions deducted under Section 187-191 to include countries affected, numbers and amounts.
- Could you please state whether Chinese State pensions became subject to Section 187-191 from July 1 2022.

Please see the **Appendix** for a table showing the number of Overseas Pension (OSP) deductions and amounts to New Zealand Superannuation (NZS) clients as at the end of June 2022, broken down by country.

I can confirm that to date, there are no Chinese State pensions which are subject to Section 187-191.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any attached documents available to the wider public. The Ministry will do this by publishing this letter on the Ministry's website. Table One Notes:

- This is a number of Overseas Pensions (OSP).
- The country given is where the OSP is paid from.
- The annualised amount is in New Zealand dollars. It is an approximation of the annual value of overseas pensions, based on amounts and exchange rates as at the time of report.
- Figures are current as at the time of reporting. However, these may be subject to change due to new historical information being recorded into the Ministry systems.
- Post-June 2016 numbers and deductions are calculated using and improved methodology, which excludes some OSP records that are in the system but not deducted from the recipients NZS.
- To protect confidentiality the Ministry uses processes to make it difficult to identify an individual person or entity from published data. These data tables have had random rounding to base three applied to all cell counts in the table. A value of one or two may be rounded to zero or three. The impact of applying random rounding is that columns and rows may not add exactly to the given column or row totals. The published counts will never differ by more than two counts.
- In certain circumstances low numbers may potentially lead to individuals being identified. Due to these privacy concerns, numbers for some categories of clients have been suppressed or aggregated. Secondary suppression rules have also been applied when required. Suppressed numbers have been replaced by an 'S'.
