On 2 August 2022, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

- In finding out how many people get a Supported Living Payment for chronic pain conditions and migraine.
- Similarly, for the Jobseeker Health Condition or Disability. And with a breakdown by age, gender and ethnicity

Your questions seek information about the Ministry's Jobseeker Support and Supported Living Payment. You may be aware that from 15 July 2013, New Zealand's welfare system changed to better help people prepare for employment. The focus is on what people can do to achieve a better future for themselves and their family. Three benefits replaced most of the previous benefit types, including the types you requested information for. These are as follows:

- **Jobseeker Support (JS)** Replaced the Unemployment Benefit, Sickness Benefit, Domestic Purposes Benefit (Women Alone, Sole Parent if youngest child is aged 14 and over) and the Widow's Benefit (without children, or if youngest child is aged 14 and over). JS is available to people who can usually work full-time.
- Jobseeker Support, Health Condition Disability (JS-HCD) Includes people who can only work part-time or can't look for work at the moment, for example because they have a health condition, injury or disability. - Supported Living Payment (SLP) Replaced the Invalid's Benefit
 and Domestic Purposes Benefit (Caring for Sick or Infirm). The SLP is
 available to people who are severely restricted or unable to work on a
 long-term basis because of a health condition or disability, and for

people who are caring for someone who needs significant care. When applying for SLP, a medical certificate from a health practitioner or suitable existing assessments, need to be provided. - A value of one or two may be rounded to zero or three.
- The impact of applying random rounding is that columns and rows may not add exactly to the given column or row totals.
- The published counts will never differ by more than two counts.

- Ethnicity data is self-identified and multiple ethnicities may be chosen by an individual as fits their preference or self-concept.
- Total response ethnicity means that if a person identifies with more than one ethnic group, they are counted in each applicable group.
- Because a client can choose more than one ethnic response, the total number of ethnic responses will be greater than the number of clients.
- MELAA refers to Middle Eastern, Latin American, and African.
- 'Not Specified' is where ethnicity is not recorded. 'Other' is where ethnicities fall outside the reported ethnicities.
- To protect confidentiality the Ministry uses processes to make it difficult to identify an individual person or entity from published data.
- These data tables have had random rounding to base three applied to all cell counts in the table.
- A value of one or two may be rounded to zero or three.
- The impact of applying random rounding is that columns and rows may not add exactly to the given column or row totals.
- The published counts will never differ by more than two counts.

Please note that from December 2021, the Ministry has changed its ethnicity reporting to an approach called 'total response'. This change reflects our clients more accurately, aligns our approach with Statistics New Zealand reporting and reflects best practice.

Ethnicity is about people's identity and sense of belonging, measuring cultural affiliation, rather than race, ancestry, nationality, or citizenship. Ethnicity is self-perceived, and people can identify with more than one ethnic group.

Previously, the Ministry reported ethnicity using an approach called 'prioritised ethnicity', meaning people were allocate a single ethnic group in an order of priority. The priority previously used by the Ministry was Māori, Pacific Peoples, Other and NZ European.
