On 25 August 2022, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

• Could you please provide a breakdown of the number and value (\$) of Special Needs Grants (SNGs) issued by the Wairarapa Community Link for the quarter ending 30 June 2022?

Please see **Appendix One** containing **Table One**, which shows the number and amount granted for Special Needs Grants from the Wairarapa Service Centre for the period 1 April 2022 to 30 June 2022, broken down by need reason.

You will note some of your requested need reasons do not appear in the table. This is because the Ministry did not receive any applications under that need reason category during the quarter.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

The Ministry will do this by publishing this letter on the Ministry's website. Notes for Table:

- This is a count of grants not clients. A client may have multiple grants in a period.
- The amount granted may not be the same as the amount spent.
- The Service Centre is based on the Work and Income site where the recommending Case Manager for the grant was based at the time of the grant.
- The 'Other' category includes Re-establishment Refugee grants.

- To protect confidentiality the Ministry uses processes to make it difficult to identify an individual person or entity from published data.
- These data tables have had random rounding to base three applied to all cell counts in the table.
- The impact of applying random rounding is that columns and rows may not add exactly to the given column or row totals.
- The published counts will never differ by more than two counts.
- A value of one or two may be rounded to zero or three.
