On 17 July 2023, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

• A breakdown of Ministry clients in the Palmerston North TLA, by whether they hold a Community Services Card, a Super Gold Card, or have a disability.

The Community Services Card is available to low- or middle-income earners to enable them and their family to access subsidised health services. Community Services Card holders can also get a 50% discount on public transport fares for themselves.

The SuperGold Card is a discount and concession card for all New Zealanders aged 65 and over, and those who qualify for New Zealand Superannuation or Veteran's Pension. It provides access to government concessions and discounts for everyday goods and services.

New Zealand Superannuation clients must meet the income test to qualify for a Community Services Card unless they are:

- Getting an Accommodation Supplement or
- Are tenants of public housing or
- Their partner is receiving an income-tested benefit

Notes for Table One:

- Territorial Local Authority (TLA) is estimated based on the client's address at the time of the card's issue.
- To protect confidentiality the Ministry uses processes to make it difficult to identify an individual person or entity from published data.
- These data tables have had random rounding to base three applied to all cell counts in the table.
- Random rounding does not round down to zero, a value of one or two will be rounded to three.
- The impact of applying random rounding is that columns and rows may not add exactly to the given column or row totals.
- The published counts will never differ by more than two counts.
