On 13 August 2023, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

 How many people who have received a \$5k to work grant for the period November 2021 to November 2022 have since had a main benefit granted?

The \$5K to Work grant is an incentive payment to assist clients to relocate when they have secured sustainable employment. The job offer must be far enough from the client's current residence that commuting to work would be financially impractical and that without locating, the job seeker would be financially disadvantaged by taking up the employment. It is expected that people who receive the \$5K to Work payment would have their accommodation arranged prior to relocation.

The recipient does not have to be receiving a main benefit from Work and Income but does need to meet the eligibility for a main benefit, for example, Jobseeker Support.

The \$5K to Work payment must be repaid if:

- A client reapplies for a main benefit or returns to study within 91 days of the job start date
- The client left their job without good and sufficient reason, or
- The client did not use the payment for the reason it was paid to them,
 e.g., securing sustainable employment and relocating.

When it is identified that a Work and Income client would benefit from assistance to relocate, staff will proactively advise clients that they may be entitled to the \$5K to Work payment. More information about this payment can be found on the Work and Income website, here:

Table notes:

- \$5K to Work is an 'incentive payment' to assist clients who have secured sustainable employment to relocate.
- The \$5K to Work payment is a non-taxable payment of \$5,000 and is not asset or income based.
- As of 1 October 2020, \$5K to Work grant came into effect.
- From 1 October 2020 the \$3K to Work grant is now \$5K to Work. This incentive payment has increased from \$3K to \$5K.
- This table only included \$5K to Work as payments for \$3K to Work ceased from 1 October 2020.
- Only the period to the first main benefit granted after the first \$5K to Work grant per client is counted here. Grants after any subsequent \$5K to Work grants are not included.
- Main benefits exclude NZ Superannuation, Veteran's Pension, Non-Beneficiary assistance, Orphan's Benefit and Unsupported Child's Benefit.
- To protect confidentiality the Ministry used processes to make it difficult to identify an individual person or entity from published data.
- These data tables have had random rounding to base three applied to all cell counts in the table.
- The published counts will never differ by more than two counts.
