Official Information Act request

Thank you for your email of 16 November 2023, requesting information about Step 2s carried out in individualised claim assessments since 2018.

I have considered your request under the Official Information Act 1982 (the Act). Please find my decision on your request set out below.

I have also included some general information about Step 2 individualised assessments at the end of this letter, for your reference.

Please provide, under the OIA, a breakdown of how many Step 2 Analyses for historic claims were carried out since 2018 until today, divided into months (or quarters, if that is more manageable).

Please provide this data both in table form, and in a bar chart or similar visual format.

The Ministry does not centrally record the date a Step 2 is completed. To provide you with this information, Ministry staff would have to manually review a substantial number of files. As such, I refuse your request under section 18(f) of the Act. The greater public interest is in the effective and efficient administration of the public service.

I have considered whether the Ministry would be able to respond to your request given extra time, or the ability to charge for the information requested. I have concluded that, in either case, the Ministry's ability to undertake its work would still be prejudiced.

We have, however, provided you with data regarding assessments featuring a Step 2, based on the date the individualised claim assessment was approved by the Deputy Chief Executive (DCE) as an estimate of when the Step 2 was completed.

Please refer to the attached Appendix which contains a table showing the number of Step 2s that have been completed in each financial year from 2018/19 to 2023/24 (to 20 November 2023) by DCE approval date, broken down by quarter. As requested, we have also provided the data in a bar chart.

General information about Step 2 Individualised Assessments

When Historic Claims is completing an individualised claim assessment (previously called claims assessment), and the allegation is of a more serious nature a Step 2 is completed. This enables the Ministry to have a better understanding of the more serious abuse alleged by those who were in care and provides confidence in the robustness of the information shared with providers, including Oranga Tamariki. It also ensures payment recommendations are fair, consistent and align with past payments. 

Notes:

- Not all individualised claim assessments will include a Step 2.
- The date that the Step 2 was completed is not recorded by Historic Claims in a reportable way. The date the assessment was approved by the DCE has been used as an estimated timeframe for when the assessment was completed.
- There may be some assessments where the step 2 was completed several months (or longer) before DCE approval of the assessment was obtained. This is may have occurred where the assessment was partially completed and then put on hold whilst the frameworks to acknowledge inappropriate detention and/or potential Bill of Rights Act breaches were developed and implemented in 2022.
- In late 2018 Historic Claims implemented a new assessment model and started completing Step 2s, previously all allegations were assessed under a different assessment model.
- Data included in this request has been captured in the Historic Claims Application (implement in November 2019). At the time of implementation, the Ministry migrated recent relevant operational data that was needed to support ongoing work. The data from some more historical claims was not fully migrated into the database. There is the possibility that information on some Step 2s, completed prior to 27 November 2019, may not have been included in the migration of data.
