On 24 October 2023, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

The number of people who are receiving the Disability Allowance as of the June 2023 and September 2023 quarter broken down by the primary cost the payment is intended for (prescription fees, heating, etc)

The aggregate total weekly amount payable to recipients of the work-ready Jobseeker support payment and the total weekly amount payable to recipients of the Disability Allowance as of the September 2023 quarter.

As at 1 April 2023, Work and Income may pay up to a maximum of \$75.10 a week for a Disability Allowance (DA), whilst children may receive \$56.60. The amount a client receives depends on the extra costs that client has because of their disability. As a part of the application for DA, clients are required to provide a Disability Certificate form, which is completed by a health practitioner, along with proof of their on-going disability-related costs (e.g., pharmacy and medical receipts and invoices, electricity bills, petrol receipts).

A client is required to advise Work and Income of any changes in their circumstances that might affect their entitlement to a DA. Furthermore, a Case Manager may also review a DA at any time to ensure a client is receiving the correct rate of payment.

Jobseeker Support (JS) is a temporary benefit paid for up to 52 weeks while clients look for work, are in training for work or unable to work due to a health condition, injury, or disability. Jobseeker Support 'Work Ready' grants, however, refer solely to those JS clients who are available for and seeking full-time employment.

- **Table Two**: The weekly amount payable for clients receiving Disability Allowance as at quarter ending September 2023
- **Table Three**: Disability Allowance cost types as at quarter ending June and September 2023 by number of recipients

To protect confidentiality, the Ministry uses processes to make it difficult to identify an individual person or entity from published data. These data tables have had random rounding where values have been randomly rounded to the nearest multiple of 3. This is applied to all cell counts in the table. The impact of applying random rounding is that columns and rows may not add exactly to the given column or row totals. The published counts will never differ by more than two counts.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and attached appendix available to the wider public. The Ministry will do this by publishing this letter on the Ministry's website. Your personal details will be deleted, and the Ministry will not publish any information that would identify you as the person who requested the information.

Table One: The weekly amount payable for working age clients receiving Jobseeker Support Work Ready as at quarter ending September 2023

As at quarter ending	Net Weekly Amount	Gross Weekly Amount
September 2023	\$33,542,356.18	\$38,323,512.20

Notes:

- The table includes working age only (18 to 64 years).
- This table only includes clients receiving Jobseeker Support Work Ready.
- The rate of benefit provided is the basic benefit rate reduced by an individual's income if they have any.
- It is not reduced by offsets and does not include supplementary assistance.
- This is a snapshot of the weekly benefit payment at given points in time.
 Adding up the values as at the end of each quarter does not equal the yearly amount payable.

Table Two: The weekly amount payable for clients receiving Disability Allowance as at quarter ending September 2023

As at quarter ending	Weekly Amount
September 2023	\$5,689,119.04

Notes:

- This included clients of all ages and all benefits, pensions, and non-Beneficiary.
- The amount of Disability Allowance costs claimed is the amount of the cost type the client has reported. It is not the amount of Disability Allowance paid for the cost type.
- Disability Allowance can be paid to a client or on behalf of a dependent.
- A client may receive one or more Disability Allowances.
- This is a table of costs declared which is more than the number of clients receiving Disability Allowances.
- The costs declared does not relate to the money paid out as Disability Allowances is capped at a maximum payment even if loaded costs exceed this.

- Where costs are logged under the "Unspecified" cost category, staff may have entered the incorrect coding when updating a client's Disability Allowance cost.
