Kia ora

On 24 September 2023, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

We note:

- The table totals don't agree (total 30 vrs 21)
- With putting all applicant postcode selections rather than the first selection or each applicant, the information doesn't have any meaning.
- The postcodes used in your table are not all Hibiscus Coast and Bays postcodes and there are also missing postcodes from the Bays area. (The information does not reflect Hibiscus Coast and Bays board)
- Does an applicant write down a suburb or a postcode on their application? Breakdown by suburb would be more useful.

How many in total are on the MSD housing list for:

- Millwater
- Silverdale
- Orewa
- Red Beach

On 27 September 2023 the Ministry emailed you to clarify your request for information. In particular, the Ministry asked which postcodes you are wanting information on.

The Ministry also explained in the clarification email, table two total was the total number of clients, with random rounding applied. If a client selected more than one area, they may appear in more than one requested letting area.

The Ministry did not receive a response to our clarification request, so your original request has been interpreted as being for the postcodes 0931 and 0932.

The Ministry used the <u>NZ Post website</u> to locate the post codes for the four suburbs you have requested information for. These four suburbs have postcodes of 0932 and 0931, the information you have requested was provided in the response dated 21 September 2023.

In a Social Housing assessment, there is a question which asks, 'In which area does the household need to live?'. The client can provide either city, town or suburb. However, the way the data is held by the Ministry is by postcodes, as there is no maximum number of areas that can be listed by the client and there is no order of preference recorded.
