Emergency Housing SNGs | Dec 2023 |

Emergency housing is short-term accommodation (usually in motels) for individuals who have an urgent need because they are unable to remain in their usual place of residence. It is funded through Special Needs Grants that clients apply for when they cannot access accommodation and we have explored all the other options available to them. Grants can cover between one and 21 nights of accommodation at a time





Commentary

The number of households in emergency housing has continued to decrease for the fifth consecutive month at 2,976 in December 2023, down by 207 (7%) compared to last month. The number of households in emergency housing in December is the lowest it has been since April 2020.

The number of Emergency Housing Special Needs Grants (EH-SNGs) has decreased by 867 last month (10%). Most regions saw a decrease in the number of households in emergency housing except the East Coast, which is still feeling the impacts of the severe weather events on housing supply, particularly in Tairawhiti.


There was \$0.8 million more granted during December 2023 than November 2023. This is due to having to make some grants for longer periods of time due to high demand on commercial supply over the holiday period in some areas and the need to secure places for those receiving EH-SNGs.





Households by duration in emergency housing - as at end of the month


















Household composition - as at end of the month



Public Housing Register | 31 Dec 2023 |

The Public Housing Register is a non-time bound list of all applicants eligible to be placed in public housing. Applicants complete a public housing assessment which determines eligibility and priority for public housing against an agreed set of criteria, which is then used to assist the public housing provider in matching to the most appropriate property.










Public Housing Register numbers













Percentage of main applicants, by ethnicity 12 - as at end of the month

Commentary

The number of Public Housing Register applications has decreased by 72 (0.2 percent) to 30,507 at the end of December 2023.

There were fewer new applications (down 612) and more applicants housed in Public Housing in December (up 108) compared to November 2023. In addition, the decrease in Register numbers in December reflects a seasonal trend since 2015, as there are fewer business days in the month.
