Emergency Housing SNGs | Aug 2023 |

Emergency housing is short-term accommodation (usually in motels) for individuals who have an urgent need because they are unable to remain in their usual place of residence. It is funded through Special Needs Grants that clients apply for when they cannot access accommodation and we have explored all the other options available to them. Grants can cover between one and 21 nights of accommodation at a time





Commentary

The number of Emergency Housing Special Needs Grants (EH-SNGs) increased by 492 from last month (a 5.8 percent increase). There was \$1.5 million more granted during August 2023 than for July 2023 (a 5.1 percent increase). This is partly due to clients being granted emergency housing for shorter durations than in July with more clients being granted 1-7 nights than 8-21 nights.


The number of households in emergency housing continues to stabilise. At the end of August 2023, the number of households decreased from July by 159 (4.5 percent). Most regions saw a decrease except Central and Canterbury which saw relatively small increases.










Age distribution of primary applicants in emergency

Public Housing Register | 31 Aug 2023 |

The Public Housing Register is a non-time bound list of all applicants eligible to be placed in public housing. Applicants complete a public housing assessment which determines eligibility and priority for public housing against an agreed set of criteria, which is then used to assist the public housing provider in matching to the most appropriate property.







Public Housing Register numbers









Percentage of applications by bedrooms required 11 - as at end of the month

Commentary

The number of Public Housing Register applications increased by 492 (1.7 percent) to 30,111 at the end of August 2023 reflecting an increase in new applications. There were an additional 516 more new applications in August 2023 compared to July 2023 (an increase of 29.5 percent). All regions except Waikato saw an increase in applications.

Anecdotally, MSD understands that the increase has been driven by a range of factors including proactive engagement by MSD staff with Transitional Housing and Contracted Emergency Housing providers (the former can take up to 30% of self-referrals) to ensure their clients have completed an assessment, renters affected by the North Island Weather Event (NIWE) testing their eligibility to long-term public housing, and further Boarding House closures.

The increase was partly offset by increases in the number of applications housed and exited from the Register for other reasons. There were 756 applications housed in August 2023 (an increase of 19 percent from July 2023) and 1,227 applications exited the register for other reasons (an increase of 52.6 percent). The increase in 'other exits' reflects MSD's focus on reaching out to register applicants that have not had contact with MSD over the last month to ensure they still require public housing, and to ensure that MSD accurately understands their housing requirements.

MSD reports total response ethnicity. This means if a person identifies with more than one ethnic group, they are counted in each applicable group and the sum of responses for all ethnic groups may exceed 100%.
