## Emergency Housing SNGs | Mar 2024 |

Emergency housing is short-term accommodation (usually in motels) for individuals who have an urgent need because they are unable to remain in their usual place of residence. It is funded through Special Needs Grants that clients apply for when they cannot access accommodation and we have explored all the other options available to them. Grants can cover between one and 21 nights of accommodation at a time.





### Commentary


The number of households in emergency housing has continued to decrease for the eighth consecutive month to 2,625 at the end of March 2024, down by 249 compared to last month. The number of households in emergency housing in March is the lowest it has been since April 2020.

The number of Emergency Housing Special Needs Grants (EH-SNGs) has decreased by 51 last month (1 percent). Most regions saw a decrease, except Northland and the East Coast, both up by 15 households.


There was \$0.05 million more and 51 fewer EH-SNGs granted during March 2024 compared to February 2024. The decrease in the number of grants this month has bucked the usual trend of monthly increases that have occurred since March 2017.


### Emergency housing - at the end of the month

## Public Housing Register | 31 Mar 2024 |

The Public Housing Register is a non-time bound list of all applicants eligible to be placed in public housing. Applicants complete a public housing assessment which determines eligibility and priority for public housing against an agreed set of criteria, which is then used to assist the public housing provider in matching to the most appropriate property.










### **Public Housing Register numbers**













Percentage of main applicants, by ethnicity

#### Commentary

The number of Public Housing Register applications has decreased by 231 (0.7 percent) to 30,678 at the end of March 2024.

This decrease is potentially due to more on hold and closure pending applications (up 372 and 258 respectively) in March compared to February 2024. Most regions saw an decrease in the number of Public Housing Register applications, except Auckland and Wellington, down by 18 and 3 respectively.

Of the 786 applicants who were housed, 405 (53 percent) were households with children, 9 more than February 2024.
