Introduction

This application form should be used by organisations requiring Accreditation to deliver home-based Out of School Care and Recreation (OSCAR) programmes. You will be assessed on the basis of the information you provide in this form, along with required supporting documentation.

The Social Services Accreditation (SSA) team is responsible for accrediting OSCAR programmes, under Sections 45-47 of the Social Security Regulations 2018.

Home-based OSCAR programmes are for children up to the age of 13, enrolled and attending school.

Home-based OSCAR programmes only operate during the following hours:

- Before-school care: 6.30am 9.00am, Monday to Friday
- After-school care: 2.30pm 7.00pm, Monday to Friday
- Holidays: 7.00am 7.00pm, Monday to Friday

SSA will only accredit home-based providers to deliver OSCAR if they are licensed by the Ministry of Education (MOE) to deliver home-based Early Childhood Education (ECE) and care services.

Home-based OSCAR organisations do not usually require a site visit. SSA may, however, conduct an on-site assessment to clarify information or respond to concerns.

Note: The maximum number of children in a licensed home-based service will be six, of which no more than four children can be using the service for ECE. The age limit for children who can receive OSCAR is 13 years.
